We are writing to provide you with an important update regarding Viatriis Ltd's Estradiol Transdermal Patches (provisional consent). Following our previous communication in July 2023, we want to inform you that our Estradiol Transdermal Patches (Mylan) will be available in an alternative registered carton alongside the existing one.



### Background

In order to ensure a consistent supply of Estradiol Transdermal patches, we have introduced an alternative registered carton for the product. This change involves an update in the carton presentation and the leaflet. It is important to note that both the existing registered carton and the alternative carton may coexist in the market. The packaging contains US Prescribing Information as a pack insert instead of the NZ Data Sheet.

Healthcare Professionals are advised to refer to the approved NZ Data Sheet for information on the product.
